Dear Parent/Carer

Year 7 Rewards' Day: Wednesday 15th July 2026

We are pleased to be able to inform you about this year's end of year Rewards' Day.

It's hoped that our Rewards' Day will continue to motivate and encourage students to perform well and achieve their best within school for the remainder of this academic year. We hope that as many students as possible will be eligible to take part in this day; we certainly look forward to a day of celebration and fun for all those taking part.

How Do Students Qualify?

Students must meet the following criteria:

1. **Punctuality:** no more than 5 late to school marks (from 2nd March)
2. **Attendance:** of 90% or above (between 2nd March and 22nd May)
3. **Attitude to Learning Score:** Average ATL of 4.5 or above
4. 500 positive points or over (by 22nd May)
5. No more than 5 Behaviour Detentions or 1 Reflection Session (between 2nd March and 22nd May)

When Do Students Find Out if They Qualify?

Students who are eligible/not eligible for Rewards' Day will be notified by parent letter w/c 8th June plus you will receive a follow up letter with details of next steps.

Important Information

- If you do not fill in the form by Friday 27th March – your child will be registered for 'Fun Day in School'
- Once the activity option is submitted – your child cannot change their mind (except in exceptional circumstances)
- Do not fill in the form more than once - only the first submission will count
- By filling in the form you are – committing to any payments required
- **If your child chooses FlamingLand** – please be mindful of travel time and possible ride queues, as July is a particularly busy time to visit
- If you do not make payment by Friday 19th June - your child will be transferred to 'Fun Day in School'
- iPay is our preferred method for payment, however cash payments can be made at the Finance Office
- Non eligible students will spend a normal working day in school (any payments made, will be reimbursed)
- Reimbursements will only be made in exceptional circumstances

We hope that our students will see this day as a goal to work towards and hope that all students will meet the necessary criteria. It really is a fun day and much anticipated by all.
