Dear Parent/Carer

Years 8 Rewards' Day: Tuesday 19th July 2022

We are pleased to be able to inform you about this year's end of year whole school Rewards' Day. After not being able to offer this much deserved day for our students for the past two years due to Covid-19, I hope this brings some good news and much needed positivity. It is hoped that our whole school Rewards' Day will continue to motivate and encourage students to perform well and achieve their best within school for the remainder of this academic year. We hope that as many students as possible will be eligible to take part in this day; we certainly look forward to a day of celebration and fun for all those taking part. To qualify for Rewards' Day students must meet the following criteria:

- Punctuality no more than 8 late to school marks from March 7th to May 27 May 2022.
- Average ATL of 4.3 or above (Attitude to Learning score) in the May data capture.
- 700 credit points or over
- No more than 3 detentions and no more than 1 inclusion session between 7th March and the cut-off point of 27 May 2022.
- ***Students who receive any form of exclusion from 7th May to the July rewards day, will not be eligible.***

Students who are eligible for Rewards' Day will be notified w/c 20th June and an email letter will be sent home with details of the next steps/payment. **For now, all students are eligible to go so long as they meet the above criteria. All students therefore, need to select in advance one option for this day from the list below:**

Activity	Cost to Parents/Carers
Flamingo Land	£36.00 (coach travel and park fees)
Fun day in school: School-based fun activities and free picnic/barbeque lunch	No Cost

To enable us to arrange activities, and the relevant fee on ParentPay, students need to decide on their choice of activity now by completing this [ONLINE FORM](#). Deadline for completion is **Friday 25th March**. **Please note:** Options cannot be changed once made, so please make your choice carefully. If more than one form is completed for a student, only the first submission will count.

Payment for the activity is not needed now or at selection. You will receive an update on when the payment window is open on ParentPay. You must use our cashless system, ParentPay; no cash will be accepted. ParentPay will be open for payment from May.

The deadline for full payment, if eligible, for the selected activity will be due by Friday 1st July. If you have any issues with the payment, affording the payment or wish to apply for the hardship fund please contact Mr Watkins via info@horsforthschool.org (subject header FAO: Mr O Watkins)

Students who are not eligible for Rewards' Day will be expected to spend a normal working day in school, studying Core subjects. Parents/Carers will be notified by letter and any payments made will be reimbursed.

We hope that our students will see this day as a goal to work towards and hope that all students will meet the necessary criteria. It really is always a fun day and much anticipated by all.
